SPACEPORT ROCKETRY ASSOCIATION AGREEMENT RELEASE

Conduct Code

All participants and associated spectators (family, friends, etc.) must refrain from using alcohol or any motor skill or mental impairing drug while attending any SRA sanctioned event other than drugs prescribed by a licensed physician. Individuals taking prescribed medication that may impair their faculties may be prohibited from participation. All participants and associated spectators must refrain from displaying unsportsmanlike behavior. SRA reserves the right to eject offenders from sanctioned events upon infraction of the Conduct Code.

Rules of Operation Summary (HPR Activities)

This summary signifies that the participant will comply with the NAR and TRA Safety Codes when participating in SRA activities.

The participant must understand and agree that his or her vehicle may be prohibited from launch if it does not pass Vehicle Check-In procedures. SRA will refund the participant's money, paid for that event only, if the vehicle fails to pass Vehicle Check-In procedures and no other vehicle is entered for launch at the sponsored event.

Participants are requested not to attempt to recover a rocket if it becomes tangled in power lines or any other dangerous place.

For HPR activities, the participant must leave igniters uninstalled until final preparation is complete. Igniters may be installed if electrically shorted until final preparation. The participant must annotate the actual (not approximated) CP/CG for multiple motor vehicle combinations (cluster or multiple stage vehicles) *on the vehicle* unless flying a vehicle of known flight stability.
